Public Art Mural Agreement

The Agreement is between Tolland TServing Thomas (Property Owner) and the City of Prescott, a municipal corporation of the State of Arizona (City).

RECITALS

- 1. The Property Owner owns the real property situated at 209 W. Gunley 54. (physical address) and is willing to make an exterior wall (Wall) available for a public art mural.
- 2. The mural becomes the property of the City of Prescott and may be removed by either party after a period of 10 years.

The parties agree as follows:

The Property Owner grants the City permission to install, maintain and remove the Mural on and from the Wall.

The Property Owner will indemnify and hold the City harmless from any and all claims, including the cost of defending claims relating to the painting, installation, maintenance and removal of the Mural.

This agreement is in effect for 10 years. After 10 years, this agreement may be terminated by either party upon 90 days written notice to the other party. Upon termination, the Wall will be restored as close as reasonably possible to its prior condition at the expense of the party who initiated the termination.

The City is responsible for the maintenance and, if necessary, repair of the Mural during the life of the Agreement. The City shall have the right to access the Mural and the Wall for maintenance purposes. The City, without penalty, may remove the Mural, if in the sole judgment of the City, the Mural is being excessively damaged.

In the event of any dispute in any manner relating to this Agreement, the parties shall submit to a bench trial in a court of competent jurisdiction, foregoing any right to a jury trial. The parties hereto expressly covenant and agree that in the event of litigation arising from this Agreement, neither party shall be entitled to an award of attorney fees, either pursuant to the Agreement, pursuant to A.R.S. Section 12-341.01(A) and (B), or pursuant to any other state or federal statute, court rule, case law or common law.
